LADY DIANA FRANCES SPENCER, H.R.H. THE PRINCESS OF WALES

... "An Uncommon Cogswell Cousin"

of the over 4,900 surnames that claim connection to Princess Diana, some are very distant, some are quite close. With a generous sprinkling of names of renown, one begins to wonder who ISN'T related to this lovely lady. AND who wouldn't be thrilled to find a connection.

To learn just how close you may claim to be as a Cogswell descendant, the pedigree that leads to your name begins with John Cogswell (1), b. Westbury Leigh, County of Wilts, England, 1592, and wife Elizabeth Thompson. Now through our most popular 2nd generation son William (2) and Susanna Hawkes we continue the trail. Then we must follow the families descending from their daughter, Hester Cogswell who married Samuel Bishop: Samuel Jr., married Sarah Fobes; Caleb Bishop married Keziah Hibbard, Lucy Bishop married Benajah Strong whose son Joseph Strong* married Rebecca Young; Eleanor Strong married John Wood, their day Ellen Wood married Franklin Work who are the last Americans in this line as their daughter, Frances Eleanor Work married Hon. James Boothby Burke Roche, 3rd Baron Fermoy, born Twyford

Abbey, Middlesex, England, 28th July 1851, who became Princess Diana's maternal great grandparents. Their son, Edmond Maurice Burke Roche

married Ruth Sylvia Gill born

Jan. 1936, married Edward John Spencer, Viscount Althorp, 8th Earl Spencer, born Sussex Square, London, 24 January 1924; these are the parents of Diana Frances Spencer, H.R.H. The Princess of Wales. There are 12 generations from John Cogswell to Diana. Any CFA member who follows this lineage exactly, from John, William, Hester, and down through Ellen Wood and Franklin Work, please give us the pleasure of inducting you into the "Uncommon Cogswell Club", soon to be announced.

Our 1996 CFA reunion in Charleston, S.C. can boast having our then-acting CFA President, now president, Edna Roberds send Princess Diana an invitation to join us with a response by a note from her secretary, on Diana's personal stationery, regretting her inability to attend.

Now that time has given an opportunity to heal the shock of Diana's death on 31 August 1997, and her will has recently been made available, I thought this article would have interest to both those of us who were aware of our Cousin Diana, and those more recent members who may not.

*An item of interest to share with you. When reviewing my files for the Courier, August edition, I found the following which seemed to hold a bit of coincidence. April, 1995, a letter from Connor M. Cogswell, CFA member and President of the Sewickley Valley Historical Society, Pennsylvania.

Dear Bernice:

The reference to Dr. Mason Fitch Cogswell on the recent CFA reunion notice got my attention as it has been scarcely a month since I heard his name at a recent program we sponsored.

It seems that a Dr. JOSEPH STRONG was serving in 1793 under the command of Major-General "Mad" Anthony Wayne at a formal military training camp called Legion Ville located on the north bank of the Ohio River 22 miles downstream from Pittsburgh. At Legion Ville General Wayne drilled the very first troops of the US Army in preparation for a battle with the Indian nations that claimed much of the Northwest Territory (present day Ohio and Indiana). Ultimately, Wayne was successful, winning a notable victory in 1794 at the Battle of Fallen Timbers.

Until recently local historians knew only the location of the Legion Ville site, having detailed knowledge of neither the camp's physical organization nor its setup. That is, until a drawing of the camp in a letter dated February 26, 1793 from DR. JOSEPH STRONG to DR. MASON FITCH COGSWELL recently was found in Yale University's Library archives.

The following is what the letter told:


February 26, 1793, DR.
JOSEPH STRONG wrote a letter
to his friend in Connecticut, DR.
MASON COGSWELL. "I was in
Pittsburgh 2 weeks, and formed
an acquaintance which was

proving agreeable to me. This place is 22 miles below Pittsburgh, situated on the North Eastern side of the Ohio on one of its highest banks. The camp is beautifully disposed at present in about 500 huts. I will draw you in a very hasty and rough draught, a pretty accurate plan of our encampment.

This place is on Indian ground and was a thick wilderness when the army arrived here the 1st of December last. The lands are cleared around for a considerable distance from camp and the place is very agreeable."

While this letter may seem incidental to the story of Princess Diana, yet it holds a very "homey" connection between her Strong and Cogswell lineage. Dr. Mason Fitch Cogswell (Jameson #481) descends from John, John, Samuel, Samuel, James, here we find evidence of a family friendship between descendants of brothers William 2 and John 2.

- SHOULD any child of mine be under age at the date of the death of the survivor of myself and my husband I APPOINT my mother and my brother EARL SPENCER to be the guerdians of that child and I express the wish that should I predecease my husband he will consult with my mother with regard to the upbringing education and welfare of our children
- 4(a) I GIVE free of inheritance tax all my chattels to my Executors jointly (or if only one of them shall prove my Will to her or him)
 - (b) I DESIRE them (or if only one shall prove her or him)
 - To give effect as soon as possible but not later than two years following my death to any written memorandum or notes of wishes of mine with regard to any of my chattels
 - (11) Subject to any such wishes to hold my chattels (or the balance thereof) in accordance with Clause 5 of this my Will
 - (c) FOR the purposes of this Clause "chattels" shall have the same meaning as is assigned to the expression "personal chattels" in the Administration of Estates Act 1925 (including any car or cars that I may own at the time of my death)
 - (d) I DECLARE that all expenses for the safe custody of and insurance incurred prior to giving effect to my wishes and for packing transporting and insurance for the purposes of the delivery to the respective recipients of their particular challels shall be borne by my residuary estate

SUBJECT to the payment or discharge of my funeral testamentary and 5 administration expenses and debts and other liabilities I GIVE all my property and assets of every kind and wherever situate to my Executors and Trustees Upon trust either to retain (if they think fit without being liable for loss) all or any part in the same state as they are at the time of my death or to sell whatever and wherever they decide with power when they consider it proper to invest trust monies and to vary investments in accordance with the powers contained in the Schedule to this my Will and to hold the same UPON TRUST for such of them my children PRINCE WILLIAM and PRINCE HENRY as are living three months after my death and attain the age of twenty five years if more than one In equal shares PROVIDED THAT if either child of mine dies before me or within three months after my death and issue of that child are living three months after my death and attain the age of twenty one years such issue shall take by substitution if more than one in equal shares per stirpes the share that the deceased child of mine would have taken had he been living three months after my death but so that no issue shall take whose parent is then living and so capable of taking ...

- 6 MY EXECUTORS AND TRUSTEES shall have the following powers in addition to all other powers over any share of the Trust Fund
- (a) POWER under the Trustee Act 1925 Section 31 to apply income for maintenance and to accumulate surplus income during a minority but as if the words "my Trustees think fit" were substituted in sub-section (1)(1) thereof for the words "may in all the circumstances be reasonable" and as if the proviso at the end of sub-section (1) thereof was omitted
- (b) POWER under the Trustee Act 1925 Section 32 to pay or apply capital for advancement or benefit but as if proviso (a) to sub-section (1) thereof stated that "no payment or application shall be made to or for any person which exceeds altogether in amount the whole of the presumptive or vested share or interest of that person in the trust property or other than for the personal benefit of that person or in such manner as to prevent limit or postpone his or her interest in possession in that share or interest"

THE statutory and equitable rules of apportionment shall not apply to my Will and all dividends and other payments in the nature of income received by the trustees shall be treated as income at the date of receipt irrespective of the period for which the dividend or other income is payable

- B IT is my wish (but without placing them under any binding obligation) that my executors employ the firm of Mishcon de Reya of 21 Southampton Row London WCIB 5HS in obtaining a Grant of Probate to and administering my estate
- ANY person who does not survive me by at least three months shall be deemed to have predeceased me for the purpose of ascertaining the devolution of my estate and the income thereof
- 10 IF at any time an Executor or Trustee is a professional or business person charges can be made in the ordinary way for all work done by that person or his firm or company or any partner or employee


THE SCHEDULE

MY Executors and Trustees (hereinafter referred to as "my Trustees") in addition to all other powers conferred on them by law or as the result of the terms of this my Will shall have the following powers

- 1(a) FOR the purposes of any distribution under Clause 5 to appropriate all or any part of my said property and assets in or toward satisfaction of any share in my residuary estate without needing the consent of anyone
- FOR the purposes of placing a value on any of my personal chattels (as defined by the Administration of Estates Act 1925) so appropriated to use if they so decide such value as may have been placed on the same by any Valuers they instruct for inheritance tax purposes on my death or such other value as they may in their absolute discretion consider fair and my Trustees in respect of any of my personal chattels which being articles of national scientific historic or artistic interest are treated on such death as the subject of a conditionally exempt transfer for the purposes of the Inheritance Tax Act 1984 Section 30 (or any statutory modification or re-enactment thereof) shall in respect of any such appropriation place such lesser value as they in their absolute discretion consider fair after taking into account such facts and surrounding circumstances as they consider appropriate including the fact that inheritance tax for which conditional exemption was obtained might be payable by the beneficiary on there being a subsequent chargeable event
- (c) To insure under comprehensive or any other cover against any risks and for any amounts (including allowing as they deem appropriate for any possible future effects of inflation and increasing building costs and expenses) any asset held at any time by my Executors and Trustees And the premiums in respect of any such insurance may be discharged by my Executors and Trustees either out of income or out of capital (or partly out of one and partly out of the other) as my Executors and

Trustees shall in their absolute discretion determine and any monies received by my Executors and Trustees as the result of any insurance insofar as not used in rebuilding reinstating replacing or repairing the asset lost or damaged shall be treated as if they were the proceeds of sale of the asset insured PROVIDED ALWAYS that my Executors and Trustees shall not be under any responsibility to insure or be liable for any loss that may result from any failure so to do

- 2(a) POWER to invest trust monies in both income producing and non-income producing assets of every kind and wherever situated and to vary investments in the same full and unrestricted manner in all respects as if they were absolutely entitled thereto beneficially
 - (b) POWER to retain or purchase as an authorised investment any freehold or leasehold property or any interest or share therein of whatever nature proportion or amount (which shall be held upon trust to retain or sell the same) as a residence for one or more beneficiaries under this my Will and in the event of any such retention or purchase my Trustees shall have power to apply trust monies in the erection alteration improvement or repair of any building on such freehold or leasehold property including one where there is any such interest or share And my Trustees shall have power to decide (according to the circumstances generally) the terms and conditions in every respect upon which any such person or persons may occupy and reside at any such property (or have the benefit of the said interest or share therein)
 - POWER to delegate the exercise of their power to invest trust monies (c) (including for the purpose of holding or placing them on deposit pending investment) and to vary investments to any company or other persons or person whether or not being or including one or more of my Trustees and to allow any investment or other asset to be held in the names or name of such person or persons as nominees or nominee of my Trustees and to decide the terms and conditions in every respect including the period thereof and the commission fees or other remuneration payable therefor which commission fees remuneration shall be paid out of the capital and income of that part of the Trust Fund in respect of which they are incurred or of any property held on the same trusts AND I DECLARE that my Trustees shall not be liable for any loss arising from any act or omission by any person in whose favour they shall have exercised either or both their powers under this Clause



- (d) POWER to retain and purchase chattels of every description under whatever terms they hold the same by virtue of the provisions of this my Will And in respect thereof they shall have the following powers
 - (i) To retain the chattels in question under their joint control and custody or the control and custody of any of them or to store the same (whether in a depository or warehouse or elsewhere)
 - (ii) To lend all or any of the chattels to any person or persons or body or bodies (including a museum or gallery) upon such terms and conditions as my Trustees shall determine
 - (iii) To cause inventories to be made
 - (iv) Generally to make such arrangements for their safe custody repair and use as having regard to the circumstances my Trustees may from time to time think expedient
 - (v) To sell the chattels or any of them and
 - (vi) To treat any money received as the result of any insurance in so far as not used in reinstating replacing or repairing any chattel lost or damaged as if it were the proceeds of sale of the chattel insured
- (e) POWER in the case of any of the chattels of which a person of full age and capacity is entitled to the use but when such person's interest is less than an absolute one
 - (i) To cause an inventory of such chattels to be made in duplicate with a view to one part being signed by the beneficiary for retention by my Trustees and the other part to be kept by the beneficiary and to cause any such inventory to be revised as occasion shall require and the parts thereof altered accordingly
 - (ii) To require the beneficiary to arrange at his or her expense for the safe custody repair and insurance of such chattels in such manner as my Trustees think expedient and (where it is not practicable so to require the beneficiary) to make such arrangements as are referred to under paragraph (iv) of sub-clause (d) of this Clause

PROVIDED THAT my Trustees shall also have power to meet any expenses which they may incur in the exercise of any of their powers in respect of chattels out of the capital and income of my estate or such one or more of any different parts and the income thereof as they shall in their absolute discretion determine AND I FURTHER DECLARE that my Trustees shall not be obliged to make or cause to be made any inventories of any such chattels that may be held and shall not be

PEOPLE, PLACES and THINGS

PEOPLE

ERVIN COGSWELL (1886-19??) was well known in Canterbury, NH during the first half of this century. The only child of Jeremiah Cogswell and Mary A. Hannaford, Ervin grew up and always lived on the family farm, now the home of Howard Moffitt at the end of Cogswell Road. Ervin taught school in Canterbury for a number of years, worked at the Eagle Hotel in Concord and was active in various civic Canterbury organizations. He was something of a local character and is especially remembered for playing the organ for church services and other important occasions.

The Cogswell collection may have come to the Canterbury Historical Society at different times and possibly from different people. It was found in CHS storage in several different boxes and in no particular order. All of the materials have been put together, filed in acid free long life storage boxes and folders, sorted and listed for easy reference.

While the papers and materials of Ervin and his father
Jeremiah form the majority of the over 400 pieces in this collection, it also includes smaller amounts of materials of his grandfather Abiel Cogswell 1794-1868, his maternal grandmother Azubah Hannaford, his mother Mary (May) Cogswell (1851-1873), his aunt Susan Cogswell Perkins (1835-?), his Aunt Eliza & Uncle George

Cogswell, and his Aunt Annie Smith.

Included in the collection are letters, executors records, cash books, financial, insurance and loan papers, social invitations, school teaching and related materials, school books and student work, Cogswell family recipes, photographs, leaflets, booklets, newspaper clippings and programs, the 1840 US Census, and material on the Cogswell relatives in Attica, NY as well as Ervin's research notes for the Carter genealogy published in the 1911 Canterbury History.

Casualties from the Battle of Vicksburg, both Union and Rebel were brought up the Mississippi to Keokuk, Iowa where Rupert Daniel Cogswell (#2022), Rank Contract Physician Surgeon, was stationed at Estis House. Little could be done but amputation. Doctors were paid \$10 an arm and \$20 a leg. Rupert's family lived across the river in Naueeoo, Illinois.

PLACES

The HOLT-COGSWELL HOUSE, aka "Red House", and on the National Register of Historic Places. 373 South Main Street, Andover, Massachusetts. Built before 1740 by Jonathan Holt, a blacksmith on land of his father, Oliver Holt. It was sold

by Thomas Holt to Samuel Cogswell (Jameson #129) who came to Andover 1764 from Ipswich and married Elizabeth Perkins March 5th of that year. It faces south with its end to the Boston road and is the well known "salt box" type.

The old paneling in the entrance hall and east room is similar to that in the Issac Abbot Tavern. A charming old corner

cupboard with scalloped shelves is a feature of the southwest room. To afford protection from the Indians the walls of the house were lined with brick to stop the arrows. Hand hewn beams held together with wooden pins give evidence of its great age. Old musket hooks may still be seen in the ceiling of a downstairs room and also in an upper chamber making it convenient to seize arms quickly in case of attack.

Jan., 1835 the house was willed to Samuel Cogswell Ir. who willed it to his son Samuel Cogswell 3rd, March 5, 1839. Samuel Cogswell 3rd willed to his sister Lucy Cogswell (Jameson #720) Sept. 25, 1881 who in turn willed the property to her niece Sarah Cogswell Mason Gould, wife of Henry E. Gould. Sarah willed it to her son Fred Gould who sold it to his sister Mrs. Emma Gould (Whipple) Otis, wife of William E. Otis of Santa Ana, California. Emma sold to Herbert W. Holt.

The house was owned and occupied by Herbert W. Holt, direct descendant in the tenth

> generation of the original Jonathan Holt, his family constituting the eleventh generation of Holts. That was as of May, 1946.

Mrs. Sharon E. Ristuccia and husband restored the after purchasing

it from Lois Carter of Bradford for \$210,000 in 1997, and are believed to be the present day occupants.

COGSWELL YACHT SETS WORLD SPEED RECORD

On August 25, 1893, the steam yacht FEISEEN, owned by William B. Cogswell (Jameson #1816), established a world's speed record on a run in New York Harbor. The yacht, 79 feet long, reached 31.6 miles

per hour or 27.46 knots, which was claimed to be a speed never before reached by any boat in the world. The previous record had been held by a Russian torpedo boat.

Cogswell, a prominent engineer and a leading Syracuse manufacturer, had always been fascinated by engine development. He had the FEISEEN built by W. Gardner and C.D. Mosher of New York at a cost of \$30,000. Mosher was a naval architect and marine engine designer, and the FEISEEN was regarded as the forerunner of a class of torpedo boats of extraordinary speed.

Sure enough, on October 28, 1893, the FEISEEN was purchased from Cogswell by the government of Brazil and was immediately altered for war service. She was fitted with a turntable torpedo tube, a rapidfire gun, and a small-calibre machine gun. Then she was taken aboard a much larger ship and proceeded to Rio de Janeiro.

At the time, the Brazilian government was facing a rebellion. Much of its navy had joined the rebels, so the acquisition of the FEISEEN gave the government a ship faster than any of the torpedo boats held by the rebels. Although the republican government of Brazil survived, newspaper accounts do not reveal what happened to the FEISEEN.

We're looking forward to seeing you in Halifax....the autumn leaves should be at their best at least that's what we're aiming for. It's difficult to be sure in advance. (Nova Scotia's Apple Blossom Festival this year was held after all the blossoms were gone because they came early.)

The best leaves require frost, so be prepared for cool nights, especially if the weather is fine. (Clouds keep the heat near the ground, so there should not be any snow.) Days should be pleasant, but those from warmer parts of the continent may still

want a sweater or light jacket. We're hoping for sunshine, but in October, there is no guarantee. There could be rain, and Halifax is noted for fog. You won't be swimming in Nova Scotia, unless it's at an indoor pool.

Halifax is closer to the equator than to the North Pole, but just barely. We'll cross the 45th parallel on our bus tour on Saturday, and our lunch will be on the North side of it, but indoors, so it's only for sightseeing that jackets are needed, any time we are off the bus. In the city - well, that depends. Days may be warm, but again, no guarantee. So come prepared for cool or wet weather - fall weather in New England or winter weather in Florida. That way, we hope any surprises will be happy ones.

FROM THE SECRETARY'S DESK

Since we have been "drifting" away from following our Bylaws it seems prudent to remind us of what they dictate in order to correct any errors in our proceedings.

Taken from Bylaws of the Cogswell Family Association, Inc.

A review of our two types of membership to keep in mind:

ARTICLE III - MEMBERSHIP

Section 1. Classification. Membership in the Association shall consist of two classifications. Ancestral and Honorary: A. Ancestral is open to any lineal descendant of John Cogswell (born 1592, died 1669), who arrived in America aboard the ship, Angel Gabriel, and settled in Massachusetts in 1635; OR persons who have joined the family by marriage. B. Honorary is open to those who are not otherwise eligible for Ancestral membership and who, through their service and actions have shown interest in the Association, and who wish to abide by the Association's Constitution and Bylaws. Honorary members may not vote.

However, one such member may serve as a member of the Board of Directors, but not serve as an Officer.

Some reminders regarding meetings:

ARTICLE IV

Section 4. Quorum: At all meetings of the general membership of this Association, five (5) ANCESTRAL MEMBERS shall constitute a quorum for the transaction of business.

And for a partial review at this time, a look at Officers:

ARTICLE V - OFFICERS

Section 1. The officers of this Association shall consist of a President, First Vice-President, Second Vice-President, Secretary, Treasurer, Historian, Chaplain and Legal Counsel, all of whom shall be Ancestral paid up members of the Association.

FROM THE EDITOR'S DESK

Now that we have been reminded of the purpose of the CFA perhaps more attention should be given to things genealogical. And that means the Courier will need to hear from those who are enjoying research.

A recent letter from CFA member Priscilla Greenlees reports hiring a researcher to work on the Elizabeth Thompson line. She will share with us any information learned. Let's share experiences, where we have found records, those discoveries that came to us that appear to be destiny at work. Such an experience was mine a few years ago while doing research in Fredericton, New Brunswick. Having "signed in" at the entrance which also requested the surnames to be researched, during my visit a lady came to me and said she had noticed my interest in the Crandlemire family. After a few moments of making comparisons, learning her husband's mother was a Crandlemire, we agreed to

meet the next day with our data. I had a picture of her husband's maternal grandfather! One neither had seen. I had no knowledge of this family until that day! It's called being at the right place at the right time, or just destiny! Perhaps some of us have town histories that are out of print; these are always full of families, especially those in the New England area. I will list a couple of mine with the offer to look for any possible reference to anyone seeking help. One such is the history of The Brett Genealogy, by L.B. Goodenow, 1915. Starting with William Brett, 1648 who married Elizabeth Cary. Mayflower people who settled Bridgewater, Mass. Alden, Cooke, Mitchel. Extensive genealogy that includes many early families in addition to the Bretts. Another is History of Martha's Vineyard in three volumes, by Charles E. Banks, 1911. Begining 1632, with family genealogies well through the 19th century. Both are well

indexed and very easy to learn of any surname included. Also I have two volumes about the Fitch families...Samuel Cogswell married Anne Mason in 1701, whose mother was Abigail Fitch. These two volumes cover the Fitch family in England as well as "the colonies".

Another way to share your ancestry is sending in your ahnentafel...this is a great way to list those many, many, names we all have in our lineage. To give this a trial send your titles, area and time period it covers, along with a few of the most popular names. Your name and address. When asking for help we all know the courtesy required as researchers to include a s.a.s.e. Let's give it a try...send me what you have to share and it will go into the December '98 Courier.


